- 1:30 LOT 13 PIONEER MOUNTAIN RANCH SUBDIVISION- PLAT AMENDMENT: Public hearing and consideration of a plat amendment application by Doug and Stefanie Bond to relocate an existing platted building envelope (BE) out of the regulatory floodplain. The 4.45 acre parcel is located at 126 Pioneer Mountain Dr. also known as Lot 13 of Pioneer Mountain Ranch Subdivision. The subject property is zoned Residential/Agricultural District (R-5), contains areas of Avalanche (A), Mountain Overlay (MOD), Floodplain Overlay (FP), and Riparian Setback (R) Districts. - 2:30 TITLE 10 SUBDIVISION REGULATIONS TEXT AMENDMENT: A public hearing on and consideration of County-initiated amendments to Blaine County Code, Title 10, Subdivision Regulations. Multiple revisions are proposed within Chapter 2, Definitions; Chapter 3, modification of floodplain and wetland mitigation plans; Chapter 4, Procedure for Approval and Plat Contents; Chapter 5, Design and Improvement Standards; and Chapter 8, Enforcement, Violations and Penalty. The amendments are primarily intended to reorganize and clarify submittal items, reorganize standards of evaluation to be less redundant, and to update the design and improvement requirements to reflect current needs and the Desired Outcomes of the Comprehensive Plan.
